Official complaint due to total miss-function of the police

Dear readers

I hereby wish to make an official complaint as to the total non function of the local Waalwijk police.

On Saturday afternoon 2nd September 2017 at Massenetstraat 15.

My first thought was to take this matter to the National Police Corps or the Police Ombudsman but was advised to hand this matter to the Municipal offices in Waalwijk. I very sincerely hope that action will be taken and i will not need to take further steps in this matter.

Reason for complaint:

I was requested by Mrs. G.W.E. Verstegen to go and sit with Mr. Peter-Johan Maximiliaan van Lieshout, known to me as 'Dr MAX'; we both look after the children as and when requested. He was there Saturday 2nd September and was looking after the children and was staying at 15 Massenetstraat, Waalwijk at the specific request of Mrs. Verstegen (further to call "Trudi".

When I got there, Dr. Max was being questioned by a policeman while about 5 others were also present. He was instructed to show his identity as well as to state his function and all training ever done. This was done in a very degrading and belittling manner by a young policeman with a black beard. Why did the police need to know where he had studied and what degrees he has? Also, what was the reason they searched the home? The police also wanted to know the exact whereabouts of Trudi. He, Max, was there at her request to look after the children!

A policeman at first refused to allow Dr. Max to leave the home as he was disgusted with the way he was being treated. He is not a recalcitrant child but a very educated man!

He tried to explain who I was and he was then told to leave the home immediately.

He is a trusted person in her home and was present at Trudi's very specific request too. He is the family advisor and has every right to be there, 24/7 if needed.

Trudi and I live close to each other and I have witnessed much abuse by her ex husband. He is doing his best to break up the family and he does all he can to make their lives a total misery. She is terrified of him. He is a fake and extremely two faced person. He pretends to be nice but he is always angry underneath. I understand her fear too well as I was in a very similar boat. He is a congenital liar and plays one person against the other.

This whole situation is just one small example of his sick games. I tried to explain this to the policemen too. He is forever trying to control her, even though he is not in the home or family as such. He is constantly watching her even though he was legally forbidden to come near the home! He walks his dog close to the small garden in front of the home so he can peak inside the house. He drives past or rides a scooter past her door. He also takes photos of the home, of the cars and people visiting Trudi. Why? He tried his best to alienate her from her friends too and has managed this too. He told his daughter Nikki that he hoped I would kill them and myself too when we went in my car to Roermond for a fun girls day

out. He was not happy about this. He was not happy about anything his wife and eldest daughter enjoyed.

The second visit from the police was later that same afternoon 2nd September. Trudi called me and asked me to be there when she returned home. This as she was stressed out by the whole situation. Dr Max had advised her what had taken place. She had all but switched off the car when the police arrived again. Were they waiting round the corner?

The two policemen heard us into the lounet and started questioning us in a most intlmidating manner. The older of the two was relatively polite but the younger with the black beard behaved in a dominating manner and was trying to get Trudi to tell what he wanted to hear, which was not the truth. He wanted her to confirm the lies he had heard from her Ex. She asked who had reported her as missing. Is there not a standard 48 hour wait before this is normally acted upon? This same policeman wanted to take Trudi to the station as he tried with Dr Max. Why? He kept interrupting her and it was the same person that had treated Dr Max with total disdain. For the first time I met a soothsaying policeman. First and last time I hope! Trudi tried to explain that she was being played by her Ex Mr Splinter. Since he has the children to stay without supervision, they missbehave in a shocking manner. They now state that if they don't like what they have with Trudi they can always just go to him. They behave like he does and did when they were still together. He is not doing his children any good this way.

He is insulting towards anyone that tries or has tried to help her. He makes a habit of telling lies about her and the children, if it suites him to paint them black.

To clarify, I would like to add that he has abused the children for many years.

I arrived there early one very cold winter morning. Ed answered the door, apologised that he was wet then told me with great pride that he had just shoved his daughter under a freezing shower as she had not listened to him fast enough. Another time he threw a paso of yoghurt over her as he was not happy as to how she was dressed. She has always dressed neatly!

To do this type of thing to small children is beyond pathetic. As long as he thinks he looks good then all is well in his sick world. The children really suffer due to this.
